#### 11. 2020 Chair's report: Please provide a narrative of the past year's activity/successes/challenges: \*

The Mission Statement for the New York Section states we will be a forum for the exchange of ideas, knowledge and experiences among those interested in the Chemical Sciences in ways that promote individual and professional excellence in the Chemical Community. This theme permeates our activities. The NYACS is proud of the long-standing traditions established throughout its 129-year history as well as the dedication to change as needed to better serve our members. We offer a variety of opportunities for our members to participate in technical and social activities. In 2020 we had 3 active Subsections: Hudson-Bergen, Long Island and Westchester; and 4 active Topical Discussion Groups: Biochemical, Inorganic and Organometallic, Metrowomen Chemists and Organic. Governing the NYACS requires 11 active Executive Committees and 2 active Coordinating Committees (Eastern Analytical Symposium and MARM Steering). In addition, professional development opportunities are presented. The ACS Leadership Institute courses are offered to the Chair-Elect and YCC Chair. In addition to the activities above, we participate in the governance of scientific societies like the ACS and the Eastern Analytical Symposium, and recognize excellence through award processes. Almost all of our Councilors for the NYACS participated at both the Spring and Fall national meetings, and 20 of our members serve on different National ACS Committees. 2020 proved to be a very challenging year for everyone. With the global pandemic, the New York local section had to cancel a good number of its scheduled in-person events, including the William H. Nichols Medal Distinguished Symposium and Award Dinner (one of our premier events). The Nichols Medal Award was established in 1902 by Dr. William H. Nichols to honor a chemical scientist for outstanding original research and was first awarded in 1903. We made the difficult decision to postpone the symposium in 2020 and hold it virtually in April 2021. The Sectionwide Conference provides an opportunity to recognize those volunteers who have made major contributions to the success of the NYACS through the Outstanding Service Award. 75 Members and guests (including high school Project SEED students with poster displays) participated. In 2020, besides the traditional Nichols High School Teacher Award, NYACS also announced winners of three Outstanding College Teachers Awards. In 2020 one NYACS member received an ACS Outreach Volunteer of the Year Award. We promote excellence in society primarily through public outreach, both national and international, and our commitment to the next generation of scientists through educational activities. One outstanding event that had to be cancelled is our annual Chemists Celebrate Earth Week Seminar and Parade. The NYACS has several significant activities for middle school and high school students. 450 students registered for the US National Chemistry Olympiad (though only 380 actually took the exam). 26 teams from 4 different high schools presented posters at the 2020 Chemagination. The 2020 National Chemistry Week Chemistry Spectacular had 18 prestigious colleges, universities, industries, business centers and nonprofit organizations participate through 80 volunteers to serve 140 attendees. Project SEED also forged ahead with virtual opportunities for students. Due to COVID-19 NYACS had to cancel our premier

activity for college level students, the Undergraduate Research Symposium. The NYACS maintains an active social media presence. Our Facebook page has 613 followers with 536 likes. Our website typically has 7.7 users/day (1 min 44 sec on average), with spikes on the days of the Sectionwide conference, April 15th, and our Teaching in the Time of COVID events. We boast 2699 users (89.8% new, 10.2 returning) In January 2020 NYACS, in conjunction with the North Jersey, Princeton and Philadelphia local sections, hosted a "Synthesis of Scale" process chemistry symposium. This event was the direct result of a collaboration between these sections spawned by the ACS Leadership Conference and financially supported by a grant from ACS. The event was well attended, interesting and informative, and proved to be an excellent opportunity for members of the NY chapter of ACS to meet members from other local sections as well as for members in academia (including students) to meet members in the pharmaceutical industry. The conference was held at Rutgers university, in the Department of Chemistry and Chemical Biology building (registrants were also given the option of a building tour). While the months of March and April left us with much uncertainty for what lay ahead, our members were resourceful and determined to still be active. We quickly pivoted to using online platforms such as Zoom for meetings and seminars. Over the summer we hosted a successful series of workshops on "Teaching in the time of COVID". For National Chemistry Week we relied on live-streaming demonstrations and showing pre-recorded experiments so that the participants could still partake and learn about the wonders of chemistry! I would like to echo the concerns and challenges expressed by the 2019 Chair. We are indeed at a critical time in NYACS membership where there is a "changing of the guard". I am thrilled that the younger members are taking on more leadership roles, and they can be mentored by the more senior members. I hope this continues, but I acknowledge that it is probably a dangerous practice to rely solely on a handful of people for "institutional knowledge" regarding policies and procedures that should be documented. Our budget continues to run in deficit mode, and this simply is not sustainable in the long term.

We offer a wide variety of opportunities for our members to participate in technical and social activities. In 2020 we had 3 active Subsections and 4 active Topical Discussion Groups. We were able to establish an inactive Rockland subsection and an inactive Hudson-Bergen subsection. We actively participate in the governance of the ACS. Almost all NYACS Councilors participated at both the Spring and Fall meetings. 20 NYACS members on National ACS Committees. The Sectionwide Conference provides an opportunity to recognize those volunteers who have made major contributions through the Outstanding Service Award. 75 members and guests (including high school Project SEED students with poster displays) participated. In 2020, besides the traditional Nichols High School Teacher Award, NYACS was able to announce the winners of its 2nd annual Outstanding College Teachers Awards at three different levels. In 2020, 3 NYACS members were awarded the honors of ACS Fellows, one ACS member received an ACS Outreach Volunteer of the Year Award, another member was presented the Stanley C. Israel Regional Award for Advancing Diversity in the Chemical Sciences for the Middle Atlantic Regional Meeting of the American Chemical Society, yet another member was bestowed the James Flack Norris Award For Outstanding Achievement In The Teaching Of Chemistry, and we also are proud to have a recipient of the Distinguished Scientist Awardee. Moreover, one of our members is a recipient of the Sigma Xi Evan Ferguson Award for Service to the Society. This award is in recognition of her commitment to Sigma Xi (the scientific research honor society) beyond local chapters as well as her passion for science education and student development. We promote excellence in society primarily through our public outreach, both nationally and internationally, and our commitment to the next generation of scientists through educational activities. Some of these activities this year included Project SEED, Chemistry Olympiad and Chemagination. In conjunction with other local sections nearby (North Jersey, Trenton, Princeton and Philadelphia) NYACS participated in the first annual Synthesis on Scale symposium, held at Rutgers University. This very successful event provided our members to network with process chemists and to learn more about this exciting field. The New York Section of the American Chemical Society has held a series of virtual seminars aimed at discussing distance learning in the COVID-19 era. Particular emphasis was placed on distance learning and teaching laboratory courses in chemistry. The first event which focused on a general overview of teaching and learning chemistry online took place on June 4, 2020 and was very well attended, with over 80 participants. In the session, professors discussed various strategies and assessments that were employed, and scenario planning for the upcoming fall semester. The event was so successful that four other workshops followed! On Sunday October 25, 2020, from 11:00 am to 4:30 pm the New York Local Section of the American Chemical Society celebrated the National Chemistry Week (NCW) 2020 by hosting virtual chemistry demonstrations, a chemistry knowledge Contest through Kahoot.it, and an illustrated poem contest, celebrating the yearly theme, "Sticking with Chemistry", at: https://www.newyorkacs.org/meetings/NCW/2020 ncw.php. At the event, the New York Section presented Dr. Neil Jespersen, a chemistry professor from St. Johns University (SJU), with a NCW Distinguished Volunteer Award Plaque for his 30+ years of dedicated support of the NYACS National Chemistry Week Hands-on Demonstration Program. The program had 140+ recorded individual/group/family visits and received extremely positive feedback from students, teachers, professors, and parents. 80+ volunteers from at least 15+ area organizations helped make this year's virtual NCW events a huge success!
